



## Colorado Community Action Association Silent Auction Rules and Releases

1. Open to all US residents age 18+
2. Description and Approximate Retail Value (ARV) of the prize(s)  
Approximate value of tickets is \$148 per pair
3. All bidding must be done via website
4. Bidding will end on December 8, 2022 at 10 a.m. MST
5. If (a) an attempted notification or a prize is returned as undeliverable, (b) a potential winner does not respond to the prize-claim instructions as stated within the email or overnight mail notification, (c) any required documents are not returned within the required number of days, (d) a potential winner cannot be verified or is deemed ineligible, or (e) a potential winner is otherwise unable to accept the prize as stated, the prize may be forfeited, and an alternate winner may be selected from among all remaining entries, in Sponsor's sole discretion
